Directions to Chicago Office

### **Traveling South on the I 90/ I 94 Kennedy / Edens Expressway:**

Take the east Washington exit (51C). Turn left onto Washington. Turn left onto N. Upper Wacker Drive/N. Wacker Drive. Turn slight left onto E. Upper Wacker Drive/E. Wacker Drive. Continue just past Michigan Avenue to 111 E. Wacker Drive.

Enter the building's parking garage on your right (Systems Parking Garage, a self-park facility). Take the parking elevator to the main level lobby (Plaza Level) and check in at the front desk. You will sign in and show a picture ID and then proceed to the 28th Floor. If this garage is full, continue on Wacker Drive eastbound to Stetson St., turn right and continue to the Hyatt Regency Chicago Parking Garage.

### **Traveling East on the Eisenhower Expressway (I-290) or Traveling North on the Dan Ryan:**

Merge onto the Kennedy Expressway/I-90 W/I-94 W toward Wisconsin. Take the Lake Street/200 North exit (51A). Turn right onto W. Lake Street. Turn left onto W. Upper Wacker Drive/W. Wacker Drive. Turn slight left onto E. Upper Wacker Drive/E. Wacker Drive. Continue just past Michigan Avenue to 111 E. Wacker Drive.

Enter the building's parking garage on your right (Systems Parking Garage, a self-park facility). Take the parking elevator to the main level lobby (Plaza Level) and check in at the front desk. You will sign in and show a picture ID and then proceed to the 28th Floor. If this garage is full, continue on Wacker Drive eastbound to Stetson St., turn right and continue to the Hyatt Regency Chicago Parking Garage.

### **Traveling on Lakeshore Drive, North or Southbound:**

Exit at Wacker Drive (Upper) and continue west to 111 E. Wacker Drive.

Enter the building's parking garage on your right (Systems Parking Garage, a self-park facility). Take the parking elevator to the main level lobby (Plaza Level) and check in at the front desk. You will sign in and show a picture ID and then proceed to the 28th Floor. If this garage is full, continue on Wacker Drive eastbound to Stetson St., turn right and continue to the Hyatt Regency Chicago Parking Garage.
